### 4. REQUEST FOR VARIANCE TO CITY OF HUMBLE CODE OF ORDINANCES CHAPTER 16, ENVIRONMENT, ARTICLE III, NOISE, SECTION 16-57, OPERATION OF POWER MOWERS; CONSTRUCTION, DEMOLITION - RESTRICTED, TO ALLOW CONTRACTOR TO WORK AT NIGHT ON WILL CLAYTON PARKWAY SEGMENT A BRIDGE EMBANKMENT

City Manager Darrell Boeske presented a request from RozCo Contracting Inc. for a variance to the City of Humble Code of Ordinances Chapter 16, Environment, Article III, Noise, Section 16-57, Operation of Power Mowers; Construction, Demolition - Restricted, to be allowed to work at night (10:00 p.m. to 6:00 a.m.) to build the bridge embankment on Will Clayton Parkway. The contractor stated if they could work at night the traffic would be minimal and less disruptive. City Manager Boeske recommended approval of the variance.
